Law Day Initiative Celebrates 4th Year

On May 1, 2013, high school students learned firsthand about the legal profession at Shipman & Goodwin LLP's Law Day 2013, an annual event designed to give students from diverse backgrounds an inside view of life at a law firm. (Law Day is observed nationally each year to celebrate a commitment to the law, with activities sponsored by bar associations, courts, and schools.)

Students from Bloomfield High School and Hartford's Capital Preparatory Magnet School were treated to a "behind the bench" tour of the Connecticut Supreme Court. They also participated with lawyers, paralegals and administrative staff in panel discussions about career possibilities in the law and related fields. A dialogue, centered on students' rights, generated a great deal of curiosity as students explored real-life scenarios such as free speech versus freedom of expression and searches of students and their property.

High School Internship Celebrates 3rd Year

For the past three years, Shipman & Goodwin has partnered with Hartford's Capital Preparatory Magnet School to afford a diverse high school senior the opportunity to spend two mornings per week at the firm.

Over the course of the winter and spring, the intern learns about different areas of the law, interacts with practitioners and further develops legal reasoning, written and oral communication skills.
