Follow I-91 South to Exit 29-A (Capitol Area).  
Exit at the second ramp (Prospect Street).  
Bear Right.  
Proceed straight at light.  
The Hartford Club is 1½ blocks on the right.

**From the EAST:**

Follow I-84 West to Exit 54 (Downtown Hartford).  
Continue over the Founder's Bridge.  
At the first light turn left onto Columbus Boulevard.  
Turn right onto Arch Street (Third Light).  
At light, turn right onto Prospect Street.  
The Hartford Club is 1½ blocks on the right.

**From the WEST:**

Follow I-84 East to 52 (I-91 South).  
Follow I-91 South to Exit 29-A (Capitol Area).  
Exit at the second ramp (Prospect Street).  
Bear Right.  
Proceed straight at light.  
The Hartford Club is 1½ blocks on the right.

**PARKING:**
